1. General Information

The following guidelines on writing a bachelor thesis are intended to assist final year undergraduate students and faculty member in accounting department, faculty of business and economics at the University of Sultan Ageng Tirtayasa (UNTIRTA). These guidelines are based on *guidelines for writing a bachelor thesis* issued by the faculty of business and economics, UNTIRTA. The undergraduate student work on bachelor thesis under guidance of two supervisors. Each supervisor will be assigned by the head of accounting department by considering various criteria such as functional position and research interest. Commonly, the time frame for bachelor thesis is one semester and undergraduate student will face two exams: *thesis proposal examination and final thesis examination*. Before a student finally reach the final examination phase of her/his thesis, a thesis proposal examination will be held to help the student gaining suggestion from the thesis proposal examiners. Based on the suggestions from the proposal examiners and from the supervisors, student can finish his/her thesis and when ready, he/she can submit final draft of their thesis to the student administration office at accounting department to take the final thesis examination. Students need to hand over the bachelor thesis in 3 hard bound copies and one digital copy to the responsible examination office. The bachelor thesis should be structured following the thesis writing guidelines and must has similarity check with less than 25%.

2. Thesis structure at Accounting Department, UNTIRTA

Undergraduate thesis at accounting department content the following sections:

1. Tittle page

Gives the title of the thesis in full, the candidate's names and degrees, a statement of presentation in the form "The thesis is presented for the Bachelor degree of Accounting department at the University of sultan Ageng Tirtayasa", the department and year of submission.

2. Abstract

It should not exceed 300 words. It contains at least: summarize the appropriate heading, aims, methodology, findings, implications, and originality.

- 3. Table Of Contents
- 4. Acknowledgements
- 5. Main Chapters

1) Chapter 1: Introduction

This section should contain at least research background, motivations, questions, the purpose of study, and research contributions. The reason comprises presenting brief information on the current status of research (through literature) and drawing clearly stated scientific questions from this (s). Finally, in 1-2 sentences, describe your approach to the study questions. After reading the introduction, it should be clear which scientific or practical/applied subject is being pursued and why.

2) Chapter 2: Review of Literature

In this section, explanations concerning results from previous studies published in internationally reputable journals, international database indexed journals,

accredited national journals, national journals, and research results published in a global database indexed proceedings, and other sources with a maximum amount of 20% of the total bibliography. This section also includes hypothesis development, grad theories, and conceptual frameworks of current study.

3) Chapter 3: Research Methods

The research methods include research types, operational definitions of variables, populations, samples, data collection methods, measurement instruments (variable operationalization), and analytical techniques.

4) Chapter 4: Results and Discussions

It is preferable that this sub-chapter presented in the form of a list/table, graph/image, or other form and placed as close as possible to the discussion to provide more convenience setting for the reader to follow the description. This sub-chapter consists of:

- 1. Descriptive Statistics
- 2. Results of data quality testing and or testing of Classical Assumptions (if any)
- 3. Results of Hypothesis Testing
- 4. discussions

5) Chapter 5: Conclusions and Recommendation

The conclusion is a brief and precise description described in the results discussion chapter. The conclusion can also be interpreted as an answer to the problems raised in the thesis. This chapter also include limitations of the study, which contain the obstacles faced by researchers in conducting research beyond the control (power) of the researcher. In addition, the study also explains suggestions for future research. This section also describes the contribution and implications of the research.

3. References style

In a scientific paper, one's own results are evaluated in the context of the existing literature. For this, the origin of the related information must be fully disclosed. Each citation must be verifiable, complete, from original sources (i.e. if possible not indirectly from textbooks or popular websites) and uniformly listed.

4. Specifics Guidance for writing undergraduate Thesis (formal Aspects)

The bachelor thesis should be 12.000-15.000 words (exclude appendix) with font size of 12 point with double space line spacing. The formatting should be justified. The thesis should write in Indonesian with exception in abstract, which should write both in English and Indonesian. The English version of abstract should grammatically correct. Students can use appropriate professional proofread or software to assist them when write the English version of abstract. The text should be clearly, unambiguously and logically structured. It should contain all the information necessary for understanding and thus also enable external experts to understand the investigations and conclusions and to estimate possible errors. It must be possible to distinguish clearly between results and discussions to provide more clear explanation regarding the thesis topic.

The work should also be **systematically structured** and organized within the chapters, following the second part of this guidelines. Also, Attention should be paid to the hierarchies of headings. Chapter headings do not belong to the actual text, and text may not be placed in "outline free" space (i.e. between a heading and a subheading). **Figures and tables** must be numbered consecutively and embedded in the text. Explanatory texts for the figures are always provided below the respective figure. The titles of the tables are always above the table. Reference must be made to each figure and table in the text. The contents of the figures and tables must be discussed.

5. Appendices

In the appendix, the undergraduate thesis can include all necessary items which are too extensive to be presented in the main body. The purpose of appendix is to provide the reader with information that supports bachelor thesis without breaking up the narrative or distracting from the main purpose of the paper. It can take forms of graphics, tables, or pictures.

Wawan Prahiawan, S.E., M.M.selaku pembimbing I dan Ahyakudin, S.E., M.M selaku pembimbing II.

Tujuan dari penelitian ini adalah untuk mengetahui bagaimana pelaksanaan pemberian motivasi kerja karyawan, untuk mengetahui bagaimana pelaksanaan program promosi jabatan, untuk mengetahui bagaimana semangat kerja karyawan dan untuk mengetahui seberapa besar pengaruh motivasi dan promosi jabatan terhadap semangat kerja karyawan pada Divisi Perawatan Lapangan dan Perbengkelan PT Krakatau Steel (Persero).

Berdasarkan hasil analisis dengan menggunakan bantuan software IBM SPSS 24.0 diketahui bahwa pengaruh motivasi dan promosi jabatan terhadap semangat kerja menggunakan persamaan regresi berganda $Y = 17,323 + 0,459X_1 + 0,289 X_2$. Nilaikoefisien korelasi berganda (R) = 0,531 yang berarti bahwa terdapat hubungan yang sedang dan signifikan antara motivasi dan promosi jabatan terhadap semangat kerjakaryawan, sedangkan nilai koefisien determinasi (Kd) = 25,9% berarti menunjukkan besarnya pengaruh motivasi dan promosi jabatan terhadap semangat kerja karyawan, sedangkan sisanya 74,1% dipengaruhi faktor lain yang tidaktermasuk dalam penelitian ini. Base analysis result by using software aid IBM SPSS 24.0 are known that the effect f motivation and occupation promotion to spirit of work use regression squere equation Y = 17,323 + 0,459X1 + 0,289X2. Double value of correlation coefficient

(R) = 0,531 that mean that existed relation that and significant between motivation and occupation promotion to spirit of work employees, whereas value of coefficient determination (Kd) = 25,9% mean show level of the influence of motivation and occupation promotion on spirit of work employees, whereas the rest 74,1% influenced other factor that excluding this research. And from result F test known that Fcalculate > Ftable (12,558 > 3,14), so Ho is refused and Ha is accepted, this condition means that motivation variable and occupation promotion have significant influence to spirit of work employees at Divisi Perawatan Lapangan andPerbengkelan PT Krakatau Steel (Persero).
